Barbara O'Neill moved to approve the Corresponding Secretary's report, Jane Schreiber seconded, motion approved.

**Treasurer's Report -Kelly R. Brunarski**

**Income:** In addition to twenty-six dues payments received from 2/15 to 3/1, the BCOA received \$161.35 in income from the trophy-supported entry and sweepstakes at the Sugarbush Kennel Club show in Ohio last year. We also received \$1,763.22 from the Purina Weight Circles Program; half of which was deposited in our donor advised fund with the AKC, and half of which was received, as a check, and has been deposited to our BCOA charitable fund (for health).

**Post-deadline dues:** Two sets of dues received after March 1<sup>st</sup> were either refunded or returned, with an invitation for the individuals with lapsed memberships to reapply. Note that, by the time these dues were received, other individuals with expired memberships had already been informed by club officers of the need to re-apply.

**Liability Insurance:** Our liability insurance was in the same amount as in 2008 and has been paid. Also, three liability riders were paid for insurance coverage at the lure coursing grounds, the specialty hotel, and the adjacent park grounds and parking lot.

**Additional payments:** As approved at the previous board meeting, the videographer has been contracted to video our national specialty for the next three years. We also paid for 1,024 1-1/2" Borzoi

Medallions and 310 Futurity Medallions ordered in early January from Creative Castings. Rent on our storage locker (in Michigan) has been paid through August, 2009, and the BCOA's Spring Aristocrat has been paid. Alphagraphics was paid for their printing for end of year reports and the ballots. Alphagraphics will not invoice the BCOA for postage, and thus all postage must be paid at the time of the mailings using funds in Jan Leikam's advance.

**Beverly-Taylor Funds:** The forms to facilitate the transfer of the Beverly Taylor funds for Borzoi Rescue to Schwab have been mailed to the appropriate officers for their signatures and other required information.

Additional financial information is contained in the first quarter financial reports, to be sent to board members and club officers as a separate email attachment prior to the May board meeting.

Discussion of Ways and Means which has been assigned to the Vice President. Barbara Skinner will put together a proposal for the sale of raingear (not at the National) and will email this proposal to the Board prior to the meeting in Frankenmuth on May 18<sup>th</sup>.

Kelly Brunarski noted that we need approximately \$6K over our dues income for operating expenses each year.

Discussion regarding the expense of printing and mailing ballots. We will review our proposed Constitution changes to see if we can have ballots available for downloading from our website. This would also speed up the process for getting ballots to the membership. We could still mail to those who request it.

Discussion regarding the cost of the medals for TSEs. We go through approximately 200 medals a year.

Karen Mays moved to accept the Treasurer's report, Jan Leikam seconded, motion passed.

**Delegate's Report**

As Barbara O'Neill has not yet heard from the AKC regarding her seating as our delegate for the June meeting in Raleigh, NC, Karen Mays will call AKC on Friday, May 8<sup>th</sup> to confirm this event. Barbara O'Neill said that with airfares so cheap currently, she would like to make her reservations soon.

There was no report from out-going delegate, Jon Steele.

**Governors Reports - additions**

Jane Schreiber announced that the Potomac Valley Borzoi Club is celebrating it's 30<sup>th</sup> Anniversary show this year. She requested that BCOA send a congratulatory note in honor of this achievement. Karen Mays will send the note.

Rebecca Peters-Campbell noted that the TSE at Greenwich KC will need a medallion for Hi-Score Obedience, Veterans and Puppies, but not for Rally.

Karen Mays moved to approve the Governors Reports, Barbara O'Neill seconded, motion passed.

## **Committee reports - discussion**

### **Disaster Planning.**

Veni Harlan has submitted a very detailed report with many resources listed. R.Lynn Shell-Whitlock sent her information to help her move this site onto the BCOA server but she is having technical difficulties.

### **Health**

Ginger Jones needs a Fund-Raising Chair. If anyone is interested, please contact her. The Canine Health Foundation conference this year in St. Louis has a registration fee of \$200 per participant. Ginger Jones has generously offered to attend at her own expense if BCOA will pay the Registration. Barbara O'Neill moved to pay this for Ms. Jones, Karen Mays seconded, motion passed.

Ginger Jones reported that as she was unable to obtain a centrifuge for use at the National for Health Clinics, she purchased one herself for approximately \$180.00 and has asked for reimbursement from BCOA. Jan Leikam moved, Barbara O'Neill seconded to approve this expense. Motion passed.

### **National Specialty.**

Barbara O'Neill reported that Kay Cassella will present a proposal for the 2011 Specialty to be held in Lawrence, Kansas.

Our flea problem in 2006 at the Red Lion in Olympia, WA has hurt us for other hotels in this chain as we are unable to consider sister locations for future specialties. Robin Riel is investigating locations in Eastern Washington for 2012. This area has very good weather in the Spring.

Gale Snoddy would like to put the 2010 information sheet in the Hospitality Bags which will be given out at the 2009 National Specialty. Joyce Katona moved to allow the inclusion of information about the site, etc., with no mention of Specialty sales items in the bags. Jim Anderson seconded, motion passed.

### **Standardized trophies**

Kelly Brunarski will transport the trophies following this year's National. Jan Leikam has sent an email to Mickey Nash regarding storage and transportation to Ft Mitchell KY for the 2010 National.

The future of these trophies and their transportation and storage needs to be addressed very soon.

### **Nominating Committee**

Terry Clement has been replaced by Robin Clifford.

### **Junior Showmanship**

The BCOA webpage dedicated to Juniors has been started plus the Board's revisions to the Junior Scholarship application have been approved.

**Board meeting continued**  
**May 18, 2009**

Meeting reconvened at 3:05PM by President Pruett in Frankenmuth, MI.

**Attending** were Lydia Pruett, Karen Mays, Jan Leikam, Kelly Brunarski, Barbara O'Neill, Jane Schreiber, R.Lynn Shell-Whitlock, Lorrie Scott and Joyce Katona. Absent were Jim Anderson, Barbara Skinner and Rebecca Peters-Campbell (personal reasons). **Quorum established.**

**A proposal** to hold the 2011 National Specialty to be held the week of April 5, 2011 at the Holiday Inn Hotel & Conference Center, Lawrence, KS, was presented by Barbara O'Neill, on behalf of Kay Cassella. Rooms will be \$89/night with a 4-dog max. There is a shuttle service available to/from the Kansas City Int'l Airport. Field events will be held 6 miles from the host hotel. Kay Cassella is the Facility Coordinator. Jan Leikam moved to accept this venue, Kelly Brunarski seconded. **Motion passed.**

### **Unfinished Business**

**Specialty Judges:** Jan Leikam reported the results of the latest ballot for judges: Regular classes – Amy Sorbie, Patti Neale; Sweeps classes – K C Artley, Lorrie Scott. As top vote getters, Amy Sorbie and KC Artley will have their choice of year.

**Constitution:** Barbara O'Neill reported that as the proposed Constitutional changes have taken so long to go thru the AKC inspection process; we need to update the Life Membership clause to reflect December 31, 2009 as cut-off date of current requirements. Barbara O'Neill moved to update this clause, Jan Leikam seconded, **motion passed.**

The problems with the postal service delivery of the last ballot mailing has persuaded us to post the ballot forms on the website to be downloaded by the membership and mailed to the tabulator. Ballots will only be accepted when received by the tabulator in the prescribed manner. We will continue to mail to those members who have requested that minutes be sent via USPS.

A discussion of the Trophy Supported Entry application resulted in a clarification of the six month rule. The President's List will be used to send an explanation of the deadline with an example to further illustrate the deadline *i.e.:* a June 26<sup>th</sup> event will require an application prior to December 26<sup>th</sup> of the prior year.

### **Report of the Beverly Taylor Rescue Committee – Barbara O'Neill**

The budget for 2009 per Article X has been established by the BTRC. The amount available for disbursement is approximately \$10,000 and will be allocated as follows:

\$1500	Retained for expenses (bonding, insurance, etc)
\$3123	Matching Funds
\$4311	To NBRF for fixed expenses
\$1066	To BRNC for fixed expenses

**Jan Leikam moved to accept this budget, Jane Schreiber seconded, motion passed. (Lorrie Scott abstained from the vote due to conflict of interest)**

### **On-Line ads – R.Lynn Shell-Whitlock**

Work is continuing on this project and she will speak at the General Membership meeting to update the membership.

## **New Business**

VISA Card program– it was decided not to participate.

AKC Stand-alone 'Meet The Breeds' to be held at the Jacob Javits center in NYC, October 17, 2009. Lydia Pruett contacted the three Regional Borzoi Clubs in the NE area. None of the clubs were interested so BCOA will not participate.

President Pruett has received a request from AKC to purchase an ad (\$475.00) in the AKC Gazette in honor of AKC's upcoming 125<sup>th</sup> Anniversary. The Board felt the cost was prohibitive.

In celebration of the AKC 125<sup>th</sup> anniversary, each Parent Club has been invited to do a supported entry at the Eukanuba show in Long Beach, CA December 12<sup>th</sup> & 13<sup>th</sup>. Barbara O'Neill moved to hold a TSE with Sweepstakes, Joyce Katona seconded. Motion passed. As we are unsure of the availability of sweepstakes, Karen Mays will contact Pat Laurens to clarify this.

The 'Meet the Breeds' project is again at the Long Beach Convention center in conjunction with the Eukanuba show. In 2008 BCOA placed 4<sup>th</sup> in the Hound Group for competition for Best Booth and the Board felt we should participate again. Lorrie Scott will contact Chet Weston about the feasibility of using the same booth and report to Lydia Pruett in time to respond to AKC by the October 1 deadline.

*\*note: Chet Weston has agreed to head this effort.*

**BCOA will place an ad in the Eukanuba catalogue.** Jan Leikam moved to spend \$90 for this, R.Lynn Shell-Whitlock seconded, motion approved. Barbara O'Neill moved to support our Breed entry with medallions for BOB, BOS, WD, WB & Best BBE plus Obedience and Agility if a Borzoi entry qualifies. Cost \$45 each area of competition. Joyce Katona second, **motion passed.**

A clarification of the Championship Medal requirement was done concerning the co-owner position. We reviewed the current policy and determined it was adequate and did not need revising.

We received correspondence from the International Kennel Club, Chicago asking that BCOA support their 2010 show. Joyce Katona will contact her Region 6 members asking for their input on this matter.
